

At the Faculty of Medicine the following tenure track professorship funded by the Tenure Track Programme of the German Federal Government and the Federal States has to be filled as soon as possible:

W2 Professorship „Preclinical drug development – experimental therapies“ (with Tenure-Track)

**(Position will be initially offered for 5 years)
(reference number TT 1/2020)**

We are looking for a nationally and internationally recognized personality, who can represent the field of pharmacology in research and teaching for medical or pharmaceutical students. We expect the applicant to strengthen to the field of molecular and cellular communication.

Successful applicants distinguish themselves by experience in teaching at a university and educational eligibility. A license to practice pharmacy or medicine is desirable, but not a prerequisite for an appointment. A favorable publication record and independent grant application are expected, including a specific methodological expertise and experience in at least one of the following fields: cellular signal recognition and transduction and their targeting by pharmacological modulators, the identification and optimization of new pharmacological drugs or the application of new drugs in preclinical experimental animal models.

Within the fourth year after the appointment, a tenure evaluation will be conducted under the Regulations on the Constitution, Procedure and Evaluation of Tenure-Track-Professorships at Leipzig University (TTO). The evaluation procedure is based on a binding, mutual evaluation agreement concluded at the start of employment, which sets out the development goals and expectations with regard to the professor's individual performance in the categories of research, teaching, knowledge transfer as well as academic and non-university commitment. After successful tenure evaluation, appointment to a permanent W2 professorship pursuant to Section 59 (2, no.1) of the Saxon Freedom of Higher Education Act (SächsHSFG) will take place without re-advertising the vacancy.

Applicants must meet the requirements of § 58 SächsHSFG. Rights and obligations of the jobholder are within the Saxonian university law and the Saxonian public service task regulation (Sächsische Dienstaufgabenverordnung, DAVOHS).

The University of Leipzig emphasizes the equality of women and men. Handicapped applicants are encouraged to apply and given preference if equally qualified.

Applications with the usual documents, enclosing detailed CV, a list of the scientific work and academic teaching including available records of teaching evaluations and a certified copy of the certificate of the highest acquired academic degree should be sent, preferably also in a digital format as one PDF-document, by 6 weeks after publication to:
